 Student government, Team/club sport Captain, JROTC, Scouting (Eagle/Gold Award) How can a student apply early action or early decision to a college or university in the hopes of attaining a 4 or 3 year ROTC scholarship but won't have that benefit decided yet while still applying to say a "Reach University" that may look and give a positive decision based on having an ROTC scholarship, like it normally does in the normal application timeframes?

The main questions that I am hoping will be answered all pertain to the nomination process for the service academies. I mainly want to know when to apply for them and the best process that I can take to effectively increase my chances of gaining a nomination

- In Hawaii, congressional nomination applications are due around October 15. Go online early and apply per their instructions
- If you receive an interview request
 - Prepare and rehearse
 - Dress appropriately
 - May be virtual or in person plan accordingly
 - Strong intro: "Tell us about yourself and why you are applying to the Academy and willing to serve in our Armed Forces"
 - Leadership, adversity, resilience, ethical dilemmas, unusual circumstances
 - Strong closing

- Seek additional instruction

If I were to apply for a scholarship, would it limit my choices of what major I get to pick?

 Air Force ROTC Type 1-Reserved for Commanders' In-College Scholarships (CICS) offered to cadets pursuing a technical major. It pays 100 percent tuition and authorized fees at any public or private institution with an Air Force ROTC detachment.

What your career will look like while serving both active and reserve?

- Active duty= full time job, 5-year obligation for Academy grads, 4-year for ROTC scholarship recipients, 3 years for ROTC non-scholarship recipients
- Reserve component vs National Guard- the difference has to do with the nature of duty
- Reserve members operate under the jurisdiction of the DoD and may be called up to serve in times of war, in expeditionary campaigns, for humanitarian relief, and any other mission-essential function
- National Guard troops can be activated by the state Governor, and they may also be called up by the President of the United States.

What are the differences between all of the armed forces?

- Army: To fight and win our Nation's Wars
- Navy: Protects America at Sea
- Air Force: Fly, fight, and win with airpower anytime, anywhere
- Coast Guard: Ensure our Nation's maritime safety, security and stewardship
- Merchant Marine: Educate and graduate leaders of exemplary character who will serve the national security, marine transportation, and economic needs of the United States as licensed Merchant Marine Officers and commissioned officers in the Army Forces
- Study and understand the differences that help define service culture

- Military acquired job skills, training, experience, education will all transfer into civilian life
